**PUBLIC WORKS COMMITTEE MEETING
October 23rd, 2020 at 10:00 a.m., Corbeil Park Hall**

1. **Agenda** - Approved as prepared
2. **Minutes of previous meeting, August 4th, 2020 (circulated on Council agenda of September 21st, 2020)** - Approved as circulated with council agenda
3. **Declarations of Conflict of Interest** - None for this session
4. Correspondence and Information Items:
 - a) **Allen Topolnicky - Speeding on Lavigne Road** - Director of Public Works advised that 60 km signs were missing. Signs have been posted. In the new year we will place the speed sign in that area to monitor.
 - b) **Resolution referred from Council Meeting of September 22nd, 2020 - Review of the safety of the intersection of Hillside Drive and Park Drive. (Referred from Committee of Adjustment)** - Director of Public Works reviewed the design of the subdivision. The radius and the width of the road is in accordance with the subdivision design. Director advised that a few branches are in need to be removed to improve the site lines. Director of Public Works will respond to Manager of Planning and Economic Development prior to the Planning meeting of November 18th, 2020.
 - c) **Michael Turner - Concerns-Complaints** - Committee advised that they were satisfied with the work done.
 - d) **Landfill Hours - Antoine to discuss** - Public Works employees will be manning the landfill site. To work with their time schedule; it is recommended to Council that the landfill site hours be changed as follows:

April 1st to October 31st presently: Tuesday pm is 1:00 to 6:00 pm proposed will be from 12:30 to 5:30 pm (5hrs)

Presently: Saturday is 8:00 am to 6:00 pm proposed will be from 8:30 to 4:30 pm (8hrs)

November 1st Presently: Saturday is 8:30 am to 6:00 pm proposed will be from 8:30 am to 4:30 pm (8hrs)

Landfill hours are part of Schedule "A" to By-law No. 2013-15, Waste Management By-law. Recommendation to Council for an Amendment to the schedule "A" of By-law 2013-15 will be added to the Council agenda of November 10th, 2020.

Changes to the landfill hours will be placed on the Municipal Website, Social Media and will be posted at the landfill site.

5. **Referred to new year:**
Anita Grenon - Ridgemount Crescent - signs - Director of Public Works advised that he would purchase approximately 50 signs and we will have them on hand to give to residents that feel the need to place one on their lawn.

Prior to scheduling a date for the next meeting, the Committee requested information regarding Community Safety Zone from the last Public Works Committee meeting. Director of Public Works is recommending that a By-law for Community Safety Zone is prepared and brought forward to the next Council Meeting of November 10th, 2020. The Committee approved of the Director's recommendation.

As well from past meetings of the Public Works Committee, Director of Public Works advised that he should have a reply from MTO pertaining to School Zone on Hwy 94.

Director of Public Works as well presented to the Committee with the data imported from the Speed Signs. Data will be brought forward to PSB.
