Thank you for forwarding the attached letter. We are happy to review the request from East Ferris and will respond with regard to how Public Libraries are required to apply once the matter has been thoroughly discussed.

With respect to the eligibility of number of applications, I am pleased to clarify that organizations are currently able to apply one time per deadline. OTF offers three deadlines per year, which means technically an organization can apply three times in one year. Each of those deadlines is a different stream which means an organization can apply one time per year to each stream.
